CONSIDERATION OF REGISTRATION for _____ team

1. Team members Bound by Rules, Regulations and Policies of the Plenty Valley Netball Association (PVNA),

By acknowledging this Registration Form, the Members of this team:-

- a) Agrees that they will comply with and observe the Rules, Constitution, By Laws and codes of conduct of the Association as they are presently constituted and as amended from time to time;

- c) Acknowledges that players failure to adhere to the Rules, Constitution, By Laws and codes of conduct of the Association may result in the player being de-registered and/or other sanctions.
- d) Players under the age of 18 may upon request of the association, be asked to provide proof of age.
- e) Player who swear will be sent off the court for two(2) goals. This is a junior competition and this language will not be tolerated.

2. Assumption of Risk

By acknowledging this Team Registration Form, the Team Members acknowledges and agrees that:-

- a) Netball is a non contact sport in which physical injury is likely to occur from time to time;
- b) Is none the less desirous of playing Netball; and
- c) Player takes upon them the risk (both physical and legal) of injury arising in the course of training for and participating in the game of Netball.

3. Registration of Players Under 18 Years of Age

Where the Player is under 18 years of age, by acknowledging this Team Registration Form the Parent or Guardian of the Player:-

- a) Hereby acknowledges that player has read and explained the contents of this Team Registration Form (including Conditions 1 and 2 above) to the Player;
- b) declares that the statements made in the Registration Form are to the best of the players knowledge and belief , true and correct; and
- c) The Parent/Guardian acknowledges and agrees with the Plenty Valley Netball Association that the Parent/Guardian and the Player accept the risk of the Player sustaining injury from playing Netball and forever releases, indemnifies and saves harmless, the Association their respective servants, agents, independent contractors and voluntary workers carrying out honorary or unpaid duties and each and every person participating or otherwise engaged in Netball matches (including training sessions) conducted by or under the auspices of the Association, from all actions, proceedings, demands, suits, claims, costs and expenses and other liabilities of whatsoever nature directly or indirectly arising from any injury or impairment suffered as a result of the Player's participation.
